

# Agreement Between ElySpace IT Services and NNK Travels Pvt. Ltd.

Effective Date: 2nd April, 2026

---

## 1. Scope of Work

ElySpace IT Services agrees to provide social media marketing to NNK Travels (MP, Chhatarpur), which includes:

- Running 4 Meta ad campaigns per month.
- Complimentary ad management is included (ad cost excluded).

### **Note:**

- *A full refund will be issued if the client is not satisfied, provided the request is made on or before the 30th day of the month. Requests made after this period will not be eligible for a refund.*
- *Any amount added by the client as advertising cost shall be non-refundable.*

- **Facebook Account Setup:**

The Facebook account/page will be created and fully set up by the service provider.

## 2. Payment Terms

- **Total Service Fee:** ₹5000/- per month.
- **1st Payment Date:** 22nd April, 2026.
- **Subsequent Payments:** Payment must be made at the beginning of every month.
- **Facebook Account Setup:** ₹1000/- (one-time charge).

---

### 3. Terms & Conditions

- All reels and posts will be created **without copyrighted music**.
- No inappropriate or offensive content will be used in any marketing materials.
- ElySpace shall **NOT** be responsible for guaranteed leads or conversions. Its responsibility is limited to executing the agreed-upon deliverables.
- The members of **NNK Travels** are permitted **one call per day** before the scheduled ads run. Such calls must be properly planned to ensure effective time management.

---

### 4. Content Ownership & Confidentiality

- **NNK Travels** will own the rights to all final approved content (posts and reels) upon full payment.
- Both parties agree to maintain confidentiality regarding sensitive information and marketing strategies.

---

### 5. Additional Work

- Any additional content (e.g., extra blogs, posts, or ad campaigns) outside the scope of this agreement will be billed separately at mutually agreed-upon rates.

---

### 6. Termination

- Either party may terminate this agreement with a **15-day written notice**.
- The client shall pay for all completed work up to the termination date.

---

### 7. General Provisions

- Both parties agree to communicate professionally and promptly.

- This document constitutes the **entire agreement** between the parties.
